**Cover story continued** from page 1: There are many reasons the Pull Cart is needed: Cerebral Palsy, Cerebral Malaria (weakness or paralysis), Spina bifida, deformities at birth, elderly & frail, and more. It was designed in 2007 upon request from a missionary in Zambia, Africa for those unable to crank a standard cart. The Pull Cart made up 13% of our production this year to fill orders.

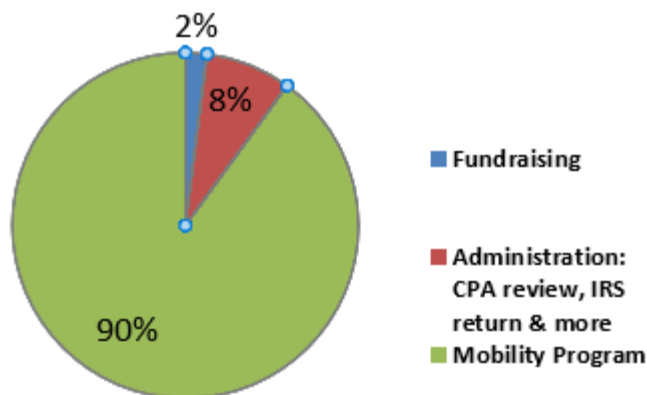
**Total revenue** for FY2025 was \$1,231,186.
